

## Information about Studio Usage (status: December, 2024)

Every freelance choreographer who is working in the genre of contemporary dance in Munich can submit an application to Tanz Tendenz München e. V. to request permission to temporarily use the studios.

The association's focal points are to provide fundamental support, relevant to the production, for freelance choreographers who create their own artistic works, as well as to promote independently funded research and production projects.

Tanz Tendenz München e. V. grants two different usage rights:

- "Production" studio usage for rehearsals of **one's own production**
- "Research" studio usage for open-ended work

**"Production" studio usage** consists of an eight-week rehearsal allotment per project with a maximum of five hours per day or a four-week rehearsal allotment per project with a maximum of ten hours per day. This usage can be spread over a time period up to six months in duration. The permitted rehearsal times are either from 10 a.m. to 3 p.m. or from 3 p.m. to 8 p.m. This scheduling is necessary to assure that the studio's capacity is used efficiently. To enable choreographers to plan their projects sufficiently far in advance, the requirement plan for the desired rehearsal times can be submitted **six months prior to the start of rehearsals**. Rehearsal schedules submitted earlier can be included in the planning with reservations, but only for half-day rehearsals. Full-day rehearsals can only be confirmed six months before the start of the rehearsal. If the desired timeframe is free, we will respond promptly and an appropriate contract will be drafted. The specific rehearsal times can be bindingly promised maximally three months in advance.

**"Research" studio usage** consists of a maximum of three hours per day on three to five days per week for up to six months. The permitted rehearsal times are either from 10 a.m. to 3 p.m. or from 3 p.m. to 8 p.m. This scheduling is necessary to assure that the studio's capacity is used efficiently. The requirement plan for the desired rehearsal times can be submitted six months prior to the start of rehearsals. If the desired timeframe is free, we will respond promptly and an appropriate contract will be drafted. The specific rehearsal times can be bindingly entered into the calendar seven days in advance.

A fee of 350 euros is payable for "production" studio usage and for "research" studio usage. If a choreographer is granted an extension of the period of studio usage within one calendar year, then the choreographer pays a total of maximally 400 euros in this calendar year.

The usage is governed by a contractual agreement between the applicant and Tanztenzenz München e.V. in which the applicant agrees to comply with the rules for use of Tanztenzenz München e.v. If the user violates these rules, Tanztenzenz München e. V. has the right to terminate the contract and deny further permission to use the studio.
